Mediation participants report a high level of satisfaction because the process allows them to be "heard" and enables them to craft customized agreements that work for their unique situation.

How the Program Works

A business interested in becoming a partner in the **Adopt-A-Court** Program will be asked to:

- Identify the courthouse that they are willing to adopt - Honolulu; Ewa; Kapolei; Wahiawa; or Kaneohe.
- Designate three to four members of their management team to participate in a two-day mediation training conducted at the Mediation Center and then alternately volunteer as Court Mediators one morning or afternoon each week.
- Commit to participating in the Program for a minimum of eighteen months.

About the Training

- The Mediation Center will conduct an interactive two-day mediation training to provide the managers volunteering as mediators, with a comprehensive understanding of the mediation process, skills and tools for mediating the court cases.
- Following the training, one-on-one mentoring will be provided by experienced court mediators.
- Mentoring will include a mediation demonstration by the experienced mediator, co-mediations, and observations of the manager mediating followed by feedback from the mentor.
