Previously, Ms. Alther designed and managed multimillion-dollar programs to support disaster relief, conflict zone aid, and resilience in marginalized communities in the US, Myanmar, Pakistan, Nepal, Gaza, Colombia, Haiti, and beyond. She recently worked with the UNFPA Arab States Office to operationalize their resilience framework in Syria and the broader region. Ms. Alther serves on the advisory committee of the Institute for Climate and Peace,

and is a founding board member and chairperson of the Campaign for Peace, Disarmament and Common Security. She earned an M.A. from Brandeis University, postgraduate certificates in leadership and peacebuilding from the East-West Center and Chulalongkorn University, and a B.A. from Texas A&M University.

Director for the Conflict Resolution Alliance, a local nonprofit that aims to develop and support peacebuilders in Hawai'i.
